PRONIS and IBT Sign an Agreement to Begin Construction on the New Pacasmayo Hospital

- *The hospital is to benefit 48 thousand inhabitants of La Libertad.*

The National Health Investment Program (PRONIS) of the Ministry of Health and IBT LLC Branch of Peru, subsidiary of IBT Group, have just signed an agreement to start the construction on the new Pacasmayo Hospital in La Libertad. The PRONIS General Coordinator, Architect Lydia Saccatoma, who presided over the agreement signing, noted that the bidding process undertaken by the program was conducted with the greatest degree of transparency and in compliance with the requirements and timeframes established by Law.

The renovated facility will be built on an area of approximately 8,798 m² and with materials that are earthquake resistant. The project will last 540 calendar days (18 months).

The architectural design was developed to provide the greatest degree of comfort to patients while establishing suitable environments for emergency, ultrasound, hospitalization, delivery, laboratory, diagnostic imaging, rehabilitation, pharmacy, and sterilization services, among others.

"Getting the construction of this new hospital to move forward, with a total investment of 73 million Peruvian soles, has been a joint effort with the La Libertad Regional Government. The expectations were big not only in the Province of Pacasmayo but in the entire region," noted the General Coordinator.

Daniel Querub, General Manager of IBT LLC Branch of Peru, likewise said, "We feel lucky to have the opportunity to contribute to making this new hospital a reality, ensuring access to quality health care for all Peruvians. We have been working for the last eight years to help to build the Peru of the future."
